

## MGS Committee meeting Monday 12th May at 8pm

Present- Tim, Sian, Maureen, Jean, Jane, Hans, Paul, Jo, Heather, Kathy

### 1. Sharing of membership database

We learnt from a recent, last-minute cancellation of Gospel singing that more than one person needs to have access to the list of members. Sian will send out a link to the data base to all committee members for use in an emergency when Sian is unavailable. TIM to liaise with SIAN on how to do this.

### 2. Fees from September

Maureen informed us that numbers are holding steady at about 35.

At the moment, under Jo's leadership the cost per 10 week term is £1310. (£100 per session for Jo, £30 for hall hire and £10 per term for refreshments)

Under Freya, this will rise to £1810.

Therefore, assuming a membership of 30, we would more or less break even, if the termly subscription is increased to £60

This does not take into account any venue hire for concerts which would have to come out of donations.

It was agreed to increase the termly subscription to £60 with Maureen retaining the option to reduce this in special cases eg illness but not for holidays.

This will have to be reviewed if the number of members shrinks but it was felt a termly subscription of more than £60 may deter some people.

MAUREEN will monitor this

### 3. May Fair concert

Total profit was £346.57 to be given to the May Fair.

Bar took £357. Bar expenses for drinks and licence were £216.10. Jean's expenses £11.92

Donations in buckets £217.59

It was agreed to remove publicity officer from the committee but to recruit other members to carry out specific tasks eg. publicity, web site, venue organiser.
